The Walking Classroom Web-Based Mobile App

IT DETAILS and ACKNOWLEDGEMENT FORM

We've compiled these technical details in order to ensure subscribers have the best experience with The Walking Classroom Web-Based Mobile App and to avoid delays in students being able to access it with their mobile devices. We request that IT departments confirm that school networks and devices can be used to access the app.

About The Walking Classroom Progressive Web App

This version of The Walking Classroom mobile app is a progressive web app that will run in most web browsers both on mobile devices and computers. (Both Apple and Android/Windows.) Functionally the same as our traditional app from the app stores, our web-based app:

- · Requires no download
- Offers the ability to add a shortcut icon to device home screens
- Uses less data/resources on devices
- Requires no updates
- Uses https for safe access

Users are Pre-Registered

After purchase, users are pre-registered within our system to enable immediate access to all app content (rather than requiring an in-app subscription as with our traditional app). Pre-registration requires that:

- The school/teacher/purchaser populates the provided spreadsheet with user information including:
 - student first name
 - student last initial
 - student email (or a unique student identifier* in the form of an email)
 - student passwords
 - the same information for each teacher using the program (but with full last name)
- Users are uploaded by Walking Classroom personnel to our system
- Sample accounts are tested by Walking Classroom personnel

Our app privacy policy addresses COPPA, CIPA, and FERPA requirements. Access the full privacy policy here.

Device and OS Minimum Requirements

For mobile devices: Optimized for iPhone 8 and up running iOS 10 and above, and Android devices that can run Google's Oreo 8.1 and above. Most tablets running those same operating systems should work fine. Mobile devices can use most any browser, but the app is optimized for Safari on Apple devices and Chrome for Android devices.

For computers: Recommend computers 2-3 years old and newer, both Windows and Mac. The app will work in most browsers but is optimized for Google Chrome.

Domain Whitelisting

The network will need to allow access to **https://app.thewalkingclassroom.org**. Please see our <u>Privacy Policy</u> for security concerns.

User Reports

If the Support Contract is also purchased, then teachers have the option to request reports that indicate podcasts that were opened by their students. Please note that in some cases, user data cannot be generated because of security settings outside of TWCI control.

^{*} Note: In the event unique identifiers must be used in place of actual emails for these accounts, users will not be able to reset passwords. However, since passwords are provided via spreadsheet, this shouldn't be an issue.
